II. Declaration

4. I/We hereby agree that the corporation is free not to accept the lowest financial bid if the bid does not satisfy any statutory or other requirements including on the quality of services.
5. I/We hereby agree that the corporation council reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever and his decision shall be final.

We are fully aware that in case the contract is awarded to us, the personnel deployed by us will not have any claim for permanent employment with corporation and associated government/private bodies, and they will on no account be treated as employees of the Institute. We shall be liable to pay compensation to corporation for the loss or damage arising out of negligence or dereliction of duty/contracted obligations during the period of contract.
7. We are also aware that the contract can be terminated by me/us during the expected period of 5 years after commissioning the proposed project, which will be seen as violation of contract agreement and necessary action can be taken against me/us by the corporation.
8. It is also accepted that we will be solely responsible for the service conditions of the personnel deployed as contained under the relevant statutes under the Labour Laws and/or any other laws/Acts/Rules in case the contract is awarded in our favour.
